4: FIRST AID MEASURES

After use and before eating, drinking and smoking, wash hands, arms and face thoroughly with soap and water. After each day's use, wash gloves and contaminated clothing.

Respiratory Protection: Always use NIOSH/MSHA approved respiratory protection equipment with a universal filter type including particle filter.

Skin Protection: Suitable protective clothing. Long-sleeve shirt, long pants, shoes plus socks.

Hand Protection: Chemical-resistant gloves made of any waterproof material such as barrier laminate, butyl rubber, nitrile rubber, neoprene rubber, natural rubber, polyvinyl chloride (PVC) or Viton.

Eye Protection: Safety goggles, chemical splash goggles or face shield for eyes protection should be used. Safety showers and eyewash should be easily available.
